FirstEnergy Rebate Requirements

- Applicant must be a residential customer of Met-Ed, Penelec or Penn Power, FirstEnergy's Pennsylvania utilities.
- Rebate valid for qualified appliances purchased beginning October 28, 2009 through May 31, 2013. Rebate must be postmarked by June 7, 2013.
- All rebated products must be listed by the EPA as ENERGY STAR® qualified on www.energystar.gov.
- Rebate application must include valid customer account number, manufacturer, model number, serial number, purchase price, and store name.
- Rebate application must be accompanied by proof of purchase (legible copy of dated and itemized sales receipt).
- To be eligible for clothes washer rebate, home must have electric water heater.
- Appliance must be installed at the service address on customer's account within the service territory of Met-Ed, Penelec or Penn Power.
- Payment will be mailed to the account holder and address on record.
- Rebates are subject to available program funds.
- No warranties or endorsements of any manufacturer or product are provided.
