- Applicant must be a Pennsylvania residential customer of Met-Ed, Penelec, Penn Power or West Penn Power, FirstEnergy's Pennsylvania utilities.
- Rebate applications are valid for qualified water heaters purchased between June 1, 2018, and May 31, 2021.
- Rebate application must be submitted within **180 days** of purchase and be postmarked by June 7, 2021.
- Rebate application with valid customer account number must be accompanied by a **legible copy of the paid itemized sales receipt showing proof of purchase that includes manufacturer, model number, serial number, store/contractor name, purchase price, and date of purchase.**
- Heat pump water heaters must be ENERGY STAR®-certified with an energy factor of 2.0 or higher.
- Rebate valid for models that are 55 Gallons and under.
- Payment will be issued to the account holder and mailing address on record with the utility, and may be issued via VISA gift card.

- All rebated products must be used at the service (install) address specified on the rebate application.
